MT VEEDER set the pace racing off the rail, kicked clear in upper stretch, just lasted. BLAMEITONTHELAW tracked in behind mid-pack, commenced a move leaving the far turn while shifting six then seven wide, was gaining but too late. CONCORD FAST pursued the pace outside while six wide, was no match for the winner and lacked the needed late kick. DEPUTY'S ECHO raced off the pace outside early, asked for run five wide coming past the quarter pole, improved position. FOREST MOUSE settled off the leaders, began to advance in about the four path leaving the turn, shifted in a bit, moved between foes a furlong out and continued to improve. TRIGGER WARNING was in range five wide through the turn, shifted in a bit at the head of the lane, weakened. BLUE AZUL chased three wide and inside foes, weakened. KELLER'S GOLD was forwardly-placed inside, weakened in the stretch. COUNTERFORCE settled off the pace, saved ground into the stretch, lacked room and switched outside a foe near the sixteenth pole. BENDING SAINT was forwardly-placed chasing four wide and between runners, gave way. BERNIN SENSATION was outrun.
