6 FURLONGS. (1.08) 12TH RUNNING OF THE WOODSTOCK PURSE \$100,000 (plus \$20,000 State Bred) FOR THREE-YEAR-OLDS. By subscription of \$100 each which shall accompany the nomination and an additional \$1,000 when making entry. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: 124 lbs. Non-winners of a Sweepstakes of \$60,000 twice, 3 lbs.; Of a Sweepstakes of \$60,000 once, 5 lbs.; Of a race other than maiden or claiming or restricted allowance, 7 lbs. (No Canadian Bred Allowance) Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable fee of \$2,000, which includes the entry fee. (Closed with 15 Nominations) *Plus up to \$15,225 Ontario Sired/Ontario Bred Breeder Awards.

CURLIN'S HONOR was out well, made an early bid for the lead racing along the inside, saved ground, drifted just off of the rail entering the stretch, dueled with VERBOTEN early in the stretch and kicked clear in the final furlong. VERBOTEN broke outwards, pressed the pace racing on the outside, was three-wide on the turn, dueled in early stretch but was outfinished and held place. SUPREME AURA settled early, trailed the field while in range, raced two-wide on the turns, angled out coming into the stretch and closed well despite missing place. MARCUS broke outwards, stalked the pace racing on the inside, saved ground on the turn and chased in the stretch. BE VEVY VEVY QUIET bobbed and broke outwards, split foes to force the pace, raced two-wide on the turn, pressed the leaders turning for home but yielded.
