This race will be limited to twelve (12) horses with preference to start given to those with the highest total earnings in 2017-2018. Failure to draw in cancels all fees. Trophy presented to the winning owner. (If transferred to the Main Track, this race will be run at One Mile and a Sixteenth.).

SCHOOL BOARD PREZ squeezed a bit at the start, taken in hand to the half from the rail, angled widest past the quarter pole for clear run into the stretch and edged clear in a good effort. TAKECHARGEDELILAH good position to far turn, angled four wide for the drive but was outfinished to the wire. SNOWIE HILL had good position to far turn, rallied through the stretch, bore in late and bothered rival and went on to hold the show spot. TOUCH OF BLING bobbed at the start, tracked leader to deep stretch, steadied when foe came in through the late going and faded. LA NINA BRONCA saved ground to the stretch with no late bid in the drive when needed. MOM GENES tracked leaders for three quarters but could not go on and faltered in the stretch run. TRUE CINDER good speed to the front with heavy pressure but succumbed readily and was through. MISSAP good position to the half but began to steadily drop back from there. TUNE UP never a serious threat throughout. SOUTHERN MISCHIEF failed to menace. THE RIDER OF TOUCH OF BLING CLAIMED FOUL AGAINST THIRD PLACE FINISHER SNOWIE HILL FOR INTERFERENCE IN DEEP STRETCH BUT THE JUDGES FOUND NO EVIDENCE TO CHANGE THE ORDER OF FINISH.
