CAJUN FIRECRACKER bumped at the start then rated in early stages the hustled up in the turn, came under strong left handed drive to move outside of FULLY LOADED, continued gain on rival then reached equal terms with sixteenth left to run, got bumped into and carried out by FULLY LOADED, kept on gamely and prevailed. FULLY LOADED pressed the early pace then edged up matching strides for the lead mid-turn, continued duel into the stretch, under vigorous right handed drive, held slim lead then drifted out and into CAJUN FIRECRACKER when rival up to challenge in final sixteenth, continued fight back then lacked final kick. GARTER AND TIE slightly bobbed at the start then rated along outside, picked up the pace then came under strong left handed drive, responded and gaining on late lead then forced wider losing stride in final sixteenth, continued close to wire. JACKSON set a pressured pace then duelled for the lead with FULLY LOADED mid-turn, continued to battle back along inside into final furlong then faded late. CAJUN EMBERS brushed at the start then unhurried racing in last flight, raced wide upper stretch then angled in closer and finished with response. TAKE COMMAND broke in bumping with foe at the start, set down driving two to three wide with response in the turn then flattened out in the lane. COSMIC SHIFT raced off the pace then hustled up in the turn, driving two wide into stretch to no avail. NACHO PAPA stubborn to load, brushed between at start, showed early response then retreated. GARBAR BOY was never too far back in early going then faltered near three eighths pole. ARBA saved ground and failed to factor. STEWARDS POSTED INQUIRY AND RIDER OF .9 LODGED CLAIM OF FOUL AGAINST .7 FOR INTERFERENCE IN DEEP STRETCH, STEWARDS DETERMINED .6 FULLY LOADED WAS GUILTY PARTY BY DRIFTING INTO CAJUN FIRECRACKER WHO THEN CARRIED .9 GARTER AND TIE OUT WIDER LOSING STRIDE, .6 FULLY LOADED WAS DQ FROM SECOND AND THIRD
