LOOMS BOLDLY coaxed from the gate, dueled from the two path with ANDIAMO AFIRENZE to the outside, tucked inside through the turn coming under coaxing near the quarter pole, took the inside route into upper stretch, edged away under a drive to the eighth pole, dug in under growing late threat and held safe. ANDIAMO A FIRENZE broke out at the start bumping D'ONT LOSE CRUZ, came under hustling and dueled three then two wide with the aforementioned foe to his inside, got placed to coaxing near the five-sixteenths, swung three to four wide into upper stretch, dug in and was shaken off a furlong out, ran on to come again latching on the winner as he hit the finish. WHAT'S UP BRO chased along the inside down the backstretch, got out a bit into the turn and had the riderapply a firm left grip while in the two path, came under coaxing near the quarter pole and went five wide into upper stretch, kept on to secure the showhonors. D'ONT LOSE CRUZ bobbled at the break and was bumped between foes who each broke his way, chased four then three wide under coaxing from the three-eighths, angled five wide into upper stretch and weakened. BOBBY RIDE broke in at the start and bumped with D'ONT LOSE CRUZ before being shouldered due to pressure inside from ANDIAMO A FIRENZE, chased five paths off the inside down the backstretch before tucking inside through the turn, continued in the inside route into upper stretch and trailed throughout.
