STAGE LEFT broke a half-step slow the dropped back, settled off the pace, was roused in the two path on the turn, turned into upper stretch under a drive and finished willingly for the show. DRAFTED bum ped with a foe at the start and was off a half-stepslow, move out while settling off the early pace, raced inside early on the turn then shifted thr ee wide later on that bend, came five wide into the stretch hand lacked theneeded response. BEREN bum ped with a rival at the start then was hustled, moved up to get the lead near the nine-sixteenths then vied inside of a foe, raced inside on the turn, lost the lead nearing the quarter-pole, battled under a drive into the final furlong and gave way. MR PHIL settle djust off the pace on the outside, was roused four wide on the turn and failedto rally.
