ANNAPOLIS broke inwardly and bumped a rival at the start, pursued from midpack along the inside while a path off of the rail, gained while shifting three wideturning for home, fanned to the six path entering the lane while taking aim, ranged up to the leader at the furlong grounds, sparked a duel, and edged an advantage late. CHURCHTOWN stalked outside of the clear pace setter, bid in the four path in upper stretch, led before meeting ANNAPOLIS's outer challenge in midstretch, dueled through the late stages, but was bested. SET PIECE (GB) broke a step slow, trailed two wide, then between horses around the far turn, encountered traffic in the five path in upper stretch, altered outwardly at the furlong grounds, and surged belated to gain show late. ENGLISH BEE tracked two wide, gotfloated four wide while getting outmoved by the eventual winner turning for home, kept on thereafter to gain show in the final sixteenth, and got nailed at the wire. STITCHED tracked along the inside, vacated the inside to take aim between horses in upper stretch, but lacked a bid, vied for show in the final furlong, but yielded. GET SMOKIN set the pace, but was nearing midstretch, and gave way. KENTUCKY GHOST was squarely bumped by an outer rival into an inner foe at the start, laid unhurried along the inside, surpassed an inner rival in upper stretch, and failed to menace. TIME TO PARTY pursued off of the pace two wide while in the bit around the first turn, raced between horses around the farturn, and failed to threaten. GRAY'S FABLE got rank leaving the gates, laid off of the pace three wide, fanned to the seven path entering the lane, and failed to factor. CAMP HOPE raced in midpack three wide, and gave way between horses in the lane. NATIVE THUNDER took a solid bump from outer rivals at the start, then saved ground off of the pace, and tired.
