CRISPY CAT (GB) vied two wide, but was outkicked by an outer bidder while yielding between horses at the furlong grounds. PRIVATE CREED stalked in the three path, floated to the four path in upper stretch, but was outkicked by an outer rival entering midstretch, and lacked a bid. AH JEEZ trailed in the two path, shifted to the six path in upper stretch, and failed to menace. GILCREASE saved ground off of the pace but to no avail. CHIRINGO broke a step slow, laid off of the pace two wide and between horses, but tired.
