In the event this race is taken off the turf it will be run on the Tapeta course at a distance of One Mile and Seventy Yards. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and Seventy Yards) (Rail at 63 feet).

BOPPY O raced in range three wide and stayed onto gain the place without threatening the winner. PEOPLE FORCE saved ground in midpack, raced three wide between foes around the far turn, waited briefly for room near the three-sixteenths, angled out nearing the eighth pole and ran onto gain the show. HARUKI prompted the winner three wide and weakened in the lane. ORDINARY saved ground and failed to menace. SEA HUNTER (IRE) chased the pace two wide early and from the rail around the far turn and lacked a closing bid. COSMIC SPECUL ATION was up close inside and retreated through the lane. TICKING lacked early speed, raced three wide around the first turn, was bumped repeated down the backstretch, went four wide around the far turn and had little left for the drive. DEVILS ONLY FRIEND veered out at the start, raced off the pace outside, was getting out and bumping a foe repeatedly down the backstretch, checked near the three-eighths pole and retreated.
