GOOD FOREVER was unhurried while in the three path through the turn, bid four wide into the lane, caught the leaders a pproaching the sixteenth pole and edged up. ZAPPINIT was checked along the rail nearing the half-mile pole, dropped back into the turn, raced in the two or three path through the turn, angled into the six path into the lane and rallied from mid-track. SPOTONJUSTICE pressed the early pace while two wide, settled off the three rival duel through the turn, chased that group into the lane, lost his path to the winner entering the lane, steadied behind rivals entering the lane, continued to look for running room to inside the sixteenth pole then offered a late gain. BUTCH'S BEST set the early pace, was joined by two rivals into the turn, dueled with those from the inside into the lane, was still aserious contender nearing the sixteenth pole and was outfinished by the top ones. CABOOSE vied for the lead three widethrough the turn and into the lane, gained a shortlead outside the eighth pole then weake ned late. SOLAR POWER was brushed at the start and settled back, raced in the three path into the lane, moved to the rail inside the eighth pole and never was a threat. FRUITCAKE never a factor while in the three path into the lane. BRUSTER JUSTICE vied for the lead from the turn, gained a short lead in late turn then faded through the lane. LOOKING GOOD LEWIS was outrun while racing in the six path through the lane. STANDOUTJUSTICE was outrun while near the rail.
