RYVIT broke a bit inward and made contact with HAVENAMELTDOWN, was quickly righted, sped to the early lead then was joined from his outside by HAVNAMELTDOWN after a furlong, sparred with that one into the turn while under some rating, inherited a clear advantage nearthefive sixteenths, was guided a few paths offther ail into the lane, opened up under brisk handling then held firm over a closing PRINCE OF JERICHO. PRINCE OF JERICHO, off the pace and about three to four wide, steadied behind rivals leaving thethree eighths, regrouped to advance three wide in upper stretch, worked between rivals leaving mid stretch and finished with good energy to gain. FROSTED DEPARTURE brushed with HAVENAMELTDOWN then checked near the five eighths, regrouped then edged up off the inside leaving the far turn, checked then altered out to avoid HAVENALMELTDOWN leaving the three eighths, shifted in for the drive and churned on. PROVE RIGHT chased the pace three wide, was carried out five wide nearing the five sixteenths, moved up four wide and between runners leaving the threesixteenths then flattened out late. SUPER CHOW, four wide with pursuit, drifted five to six wide entering the lane, was corrected with right handed asks then weakened in the final furlong. BRISTOL CHANNEL chased the dueling leaders, checked and altered out mid turn, angled towards the rail nearing the lane and tired. HAVNAMELTDOWN broke a beat slow and bumped with the winner, angled out then brushed with FROSTED DEPARTURE when sent up between foes nearing the five eighths, engaged the winner and dueled outside that one into the turn, sustained a catastrophic injury unseating his rider leaving the three eighths pole and was euthanized on the track. THE STEWARDS HELD AN INQUIRY INTO THE RUNNING AROUND THE TURN BUT NO ACTION WAS TAKEN.
