AMBASSADOR LUNA showe dvery bri ef speed chasing the lea ding pair under encoura ge ment but soonsteadily dropped back three then two wide, failed to rally. BASALT STREET chased from mid-pack going three wide on the turn and within range of the leaders but dropped back andfaded.
