SONNY SMACK raced off the pace on the outside through the opening half mile, continued around the far bend in the two path and gained ground steadily on the outside to the wire. TONKA WARRIOR hit the gate leaving it, saved ground around the first turn, raced off the pace on the inside up the backstretch, continued to save ground around thefar bend and gained ground late in the stretch. MAX K. O. saved ground early, chased the leader up the backstretch, challenged from the two path around the first turn, led the field up the backstretch, dueled while saving ground around the far turn and in upper stretch and weakened late. THE RIDER OF HORSE SIX, STAGECOACH BOYS, FILED AN OBJECTION AGAINST HORSE FOUR, FUERTEVENTURA, CITING INTERFERENCE IN UPPER STRETCH. UPON REVIEW, NO CHANGES WERE MADE TO THE ORDER OF FINISH.
