LURE HIM IN stal ked in the four path, bid around the far turn, took a narrow lead from the five path into the stretch, but was caught by an outer foe nearing the sixt eenth pole to place. SOUPER LEGACY settledup close in the three path, bid between foes around the far turn, kept on to sustain that bid from the four path down the stretch, but evened out late to show. CASHIER CHECK was held up in the five path, under a ride early around the far turn, received left handed cues while in the seven path entering the lane, but was one paced. UNO TIGER bumped with an inner foe at the start, trailed in the four path, was ridden in the six path around the turn and fanned out to the eight path into the stretch, but was no factor. MERLIN steadied between foes around the first turn, rated in the three path down the backside, was under urging turning into the lane, but weakened. SOCIALLONGDISTANCE bumped with an outer foe at the start, raced off the pace inside but failed to menace. INDY LYON set the pace in the two path but yiel ded turning into the stretch.
