SQUIRE CREEK brokeoutwardly, prompted the pace outside of the lea der and from the three path, bid at the five sixteenths pole, but was repelled entering the lane and gave way before losing place to an inner foe at the sixteenth pole. DAMON'S MOUND trac ked the leaders early on, chased the $m$ from the four path around the turn, but failed to keep pace enter ing the lane, sustaineda chase outside of foes thereafter, shifted out slightly at the sixteenth pole but lackeda bid. FROSTED DEPARTURE laid off of the pace in the two path and lacked a rally. TUMBARUMBA lac ked speed despite steady urging from the rider, failedto respond to pressure in the four path around the turn and faded. GUNFLASH trailed in the five to six path and was outrun.
