the lead then drifted out then dug in, in the final strides to take the nod. JELLI lagged early, gained ground quickly near the fivesixteenth pole, closed outside under left-handed encouragement, then ducked inside, and was out-finished. SK IP'S ROCK settled in stride awayfrom the gate then was soon joined to contend the early lead by BOOTIFUL ROSE, departed from rival nearing the quarter pole but had no response when challenged into the stretch and evened out. SHAMRA saved ground and lacked the kick nee ded. STEVIE WONDER GIRL tracked the dueling pacesetters and faded steadily inside. BOOTIFUL ROSE contested the early pace, was unable to move on with her rival, and yielded. STEWARDS INQUIRY- The Stewards conducted an inquiry into the stretch run of the race but made no change. JOCKEY OBJECTION- An objection lodged by the rider of JELLI against the rider of BIG HUG alleging interference in the stretch run was not allowed after review by the Board of Stewards.
