PRANCINGTHRUPARIS away quickly, chased outside a rival leaving the backstretch then three wide into the turn, was closest in pursuit in the two path entering the stretch and whittled the gap on the winner late. FLY A FANTASY chased widest up the backstretch, rounded the bend four wide and was along for the show. BLEVYS TIGER broke well then took hold shortly after the start, raced greenly up the backstretch and steered out, navigated the turn four then three wide and flattened in the lane. PUTT FOR DOUGH allowed to settle early, moved closer and went inside rivals into the turn, saved ground around the bend, raced a bit off the rail into the lane and weake ned. TALENT FOR GOLD forwardly placed off the rail up the backstretch, dropped back two to three wide on the turn and tired. DUE TO A TIMER MALFUNCTION THE RACE WAS HAND-TIMED.
