PUTT FOR DOUGH allowed to settle early, moved closer and went inside rivals into the turn, saved ground around the bend, raceda bit off the rail into the lane and weakened. TALENT FOR GOLD for war dly placed off the rail up the backstretch, dropped back two to three wide on the turn and tired. DUE TOA TIMER MALFUNCTION THERACE WAS HAND-TIMED.
