SMOK EM EZ took abump from outside leaving the gate, was keen early when rated between rivals, coaxed ar ound the turn in the two path and lacked the needed response in the furlong grounds. LORD PRANCEALOT veered in and bothered SHADY APPEAL at the start, went up to take control and set the pace under pressure, dueled with LASTCALL LONDON exiting the turn, relinquished the lead in upper stretch andflattene dout. SHADY APPEAL got forced in leaving the gate, pulled forward andran up on the heels of the leader early, saved ground through the bend, roused at the top of the stretch and weakened.
