COMPRESSED ENERGY reserved off the pace to be rated in mid-pack, angled to the clear turning for home and made a belated bid to gain the show. HUNGARIAN PRINCESS raced to the lead into the first turn, set a well rated pace to the far turn, and tired through the stretch. STARLET EXPRESS slow early to be at the back of the field, worked her way through traffic to be prominent turning for home and finished evenly. NO MORE FAKE NEWS went onepaced without impact. BOTOX K ATIE chased the pace from three wide and flattened out. EVIL INTENTIONS was never a threat. NO TRUST moved up to be mid-pack down the backside and was through early.
