WICKENHEISER was bumped at the break, settled off the pace two to three wide early, a dv anced mildly up the backstretch inside, bided time on the far turn, shifted seven wide into upper str etch, kicked on to get the place. FLYSOFREEASHLEEB was caught four wide throughthe initial bend, raced outside at the back, began to move four the n five wide and outsider unners on the far turn, missed second. TIME FOR AN ANGEL brokeout just a bit, moved quickly to the lead and clear to set the tempo, began to edge away up the backstretch, widened further still nearing the half to have a sizeable adv anta ge. drifted in and outthrough thestretch while weakening but kept on for the minor awar d. ME AND MY SHADOW bum ped a rival at the start, raced outside the eventual winner three wide and off the leading pair, failed to rally. BLACKDIAMOND DINNY saved ground through the first bend racing at the back, switc he dout up the backstr etch, fanned eight wide into upper stretch, ran on with mild interest but nee ded more. DELPHIA fought restraint three to four wide early, failed to rally. SEATTLE CAUSEWAY was caught five wide enter ing the initial bend gradually shifting in while chasing the leader, stalked from about two wide into the far turn, faded in the stretch.
