BUCHU settled towards the rear two to four wide, fanned six wide entering the lane, produced a good kick to offer a bid at the furlong grounds and drew clear. PHAROAH'S WINE pursued from midpack two wide, then stayed on four wide and between horses, bid for place in the final sixteenth and for ged that position late. CROWN IMPERIAL broke out and bumped a rival at the start, laid off of the pace along the inside, shifted out to the three path in upper stretch, stayed on between horses to vie for place with an outer rival late, but missed. BELLA HAZE set the pace along the inside, inched clear entering the lane, but offered no resistance to an outer rival's challenge at the furlong grounds and faded. MOONLIGHT GAMBLER trailed, advance d four wide into the far turn, fanned five wide entering the lane, but was outkicked in upper stretch and chased. SMOOTH WAVES lacked speed along the inside, searched for racing room behind foes in the four path in upper stretch and failed to factor. APPELLATE settled off of the pace two wide, fanned five wide entering the lane, shifted further out in upper stretch and moved up. ABEYANCE acted up briefly in the starting gate,, bumped with an inner rival at the start, tugged between horses early on, pursued from midpack along the inside, tracked around the far turn, chased and faded. TIME TO DAZZLE stalked along the inside while keen around the first turn, ranged up three wide around the far turn to take aim entering the lane, but hung on her left lead and weakened between horses at the furlong grounds. TOUPIE was bumped by an inner rival into an outer foe at the start, pulled while rank between foes into the first turn, tracked two wide, was urged three wide around the far turn and faltered between horses in upper stretch. ASTERNIA pressed two wide, but yielded entering the lane and weakened between horses.
