NO CHANGE made light contact with Noballstwostrikes leaving the gate then saved ground, bid nearing the five sixteenths pole, angled to the three path and took the lead midway on the far turn and dug in under steady encouragement to hold on. SO CIAL CHIC raced off the pace in the three and four paths, picked up the chase leaving the seven sixteenths pole, rounded the far turn about the six path, dug in to take second late stretch and finished well at the outside flank of the winner. MUAD'DIB stalked from the three path, gave chase leaving the seven sixteenths pole and raced close in the four path on the far turn, though, flattened stride in late yards. JUNGLE BEAST saved ground, gave chase nearing the three eighths pole, raced in the three path on the far turn and flattened stride the final sixteenth. C R'S MANDATE made light contact with Noballstwostrikes leaving the gate, started a bid leaving the seven sixteenths pole, raced off the rail on the far turn and ran evenly in the lane. CANDY INVASION raced in the five path the first turn, settled well back and could only improve his position. NOBALLSTW OSTRIKES was jostled leaving the gate then rated close inside, challenged at the nine sixteenths pole, dueled at even terms leaving the half mile pole but dropped back and gave chase from the three path the second turn and showed little response through the backstretch. LORD OF CORK raced clear into the first turn and rated the pace, came under pressure leaving the nine sixteenths pole and contested mostly even terms from that point, but weakened at the rail on the far turn. MACHEN'S RIDGE raced in the seven path the opening turn, left the second turn outside and never factored.
