EL DINERO was bumped into a rival and in tight at the start, settled well back of the leaders, saved ground, rallied inside to prevail. POP'S PEPPYSTEPER switched out early then back to the rail for the turn, saved ground inside and off the pace, came out five wide by mid-stretch, bid near the sixteenth pole but was outkicked. STOVALL was encouraged forward to press the pace from outside racing about three wide, bid in upper stretch taking the lead, was outfinished. WESTERN AFLEET was lightly bumped into a rival at the start, tracked in behind inside runners, moved out five wide by the top of the stretch in range, evened out. BLAME ME SERIOUSLY lacked early speed despite encouragement, raced toward the back in the three to four path on the urn, improved position. SUMMERTIME PEPPERS was quick to lead, set a pressured pace inside, gave way. RISING KOTO STAR was bumped at the break, guided nearer the rail then back off the rail heading to the turn, raced outside a foe in the three path, swung nine deep into upper stretch, was not a threat. A THOUSAND DOLLARS chased from outside, raced mostly four to six wide, failed to rally. PRODIGY PARADISE bumped a rival lightly at the start, chased from between runners in the second flight, faded.
