BIG EFFECT laid up close in the two path, bid from the rail going into the turn, led from the two path going into the stretch, but finished evenly to show. SAINT NO MORE set the pace in the three path, was roused between foes in the two path entering the turn, lost the lead while in the three path passing the quarter, fought on between foes, but faded late. PRIVATE THOUGHTS trailed along the rail, floated out to the five path turning into the stretch, but made no impact. LACE UP prompted the pace in the six path but gaveway turning into the lane.
