CONDENSATION unhurried early, had a mild late rally three wide. SIMPLY STATED had good early speed three then two wide and lacked the needed response. LATE FROST pressed the pace along the inside into the stretch and gave way late. ZAPPLE had brief speed six wide. POETICA brushed the gate at the start, was guided outside soon thereafter, inched closer on the turn then came up empty.
