HEADL AND, away in good order, was joined by DREAM CHASER from her inside early on, disputed the pace under rating while two to three wide, responded and moved clear soon into the lane, kept on under right handed encouragement through the final furlong and held sway. APPLE PICKER tracked the dueling leaders while about three wide, came under pressure midturn, circled four wide with aim into the lane, drifted in a bit and pinballed off of MOODY WOMAN near the threesixteenths, recovered and finished gamely to gain. DREAM CHASER was sent up to the inside of the winner early on and gained a slim advantage, sparred under coaxing slightly off the rail around the turn, ce ded command approaching the stretch, lost her footing when switching leads soon into the lane and came out a bit bumping MOODY WOMAN, corrected and kept on with effort. MOODY WOMAN , off the pace and under urging, picked up the pace three wide mid turn, edged up between rivals entering the lane, was jostled between foes soon after, recovered to pursue between horses from mid stretch to the sixteenth pole then came up empty in the final yards. WORST BEHAVIOUR, off the pace, shifted out leaving mid stretch and had belated action. I'M GITTIN THERE, towards the inside, moved up slightly inside rivals in mid stretch then flattened out. Following a stewards' inquiry into the run in upper stretch and objection by the rider of MOODY WOMAN against APPLE PICKER alleging interference in upper stretch was not allowed.
