R CALLI KIM stalked inside, was coaxed along while waiting for an opening around the final turn, bid along the inside into the stretch, and ran on, but got bumped by an inner foe around the final sixteenth, and had to settle with place. ANATOLIAN rated in the two path, was cued into the final turn, fanned out to the six path at the top of the stretch, and kept on for show. TASS laid up close in the two path, was cued to bid early into the final turn, but flattened from the four path in the stretch. ROMAGNA MIA (GB) was unhurried along the inside early, tipped out to the four path turning into the backstretch, was driven into the final turn, angled out to the six path passing the eighth pole but failed to bid. HIGHLAND GRACE tracked in the two path, tipped out to the three path down the backstretch and was cued into final turn, swung from the five path into the stretch, but weakened. VIVA LA RED laid off the pace while two wide early but never menaced. AFTER AN OBJECTION BY THE RIDER OF R CALLI KIM AGAINST THE RIDER OF ALPHA BELLA FOR POSSIBLE INTERFERENCE AROUND THE FINAL SIXTEENTH, NO CHANGES WERE MADE AS THE STEWARDS RULED THAT IT DID NOT EFFECT THE RACE RESULT,
