IRIDEO (ARG) settled at the back, moved to the rail and went inside rivals on the turn, coaxed along while stuck behind rivals off the rail in upper stretch, angled back to the inside for a clear path, surged late along the fence and nailed MUCHO DEL ORO at the wire. MUCHO DEL ORO dueled for the lead from inside then ceded command to HAMWOOD FLIER (IRE), was closest in pursuit in the two path around the bend, challenged from outside crossing the dirt, put away inner rival in upper stretch, remained clear into the final sixteenth and got caught on the line. SUMTER traveled three deep near the back early on, angled out approaching the dirt, came five wide into the lane, moved into range in upper stretch but needed to find more in the late stages. DANIEL'S MAGIC dropped back off the pace early, saved ground through the turn, roused entering the stretch and moved off the inside, chased between rivals into deep stretch and finished evenly late. HAMW 00D FLIER (IRE) dueled briefly from outside then cleared MUCHO DEL ORO, showed the way two wide then along the rail through the turn, confronted by MUCHO DEL ORO crossing the dirt, yielded in upper stretch and flattened late. JOHNNY PODRES chased three wide into the turn, moved into the two path around the bend, remained off the rail to the stretch and failed to rally. I'M A GAMBLER (IRE) traveled between rivals towards the rear in the early going, altered out from behind rival crossing over the dirt, steered out further in upper stretch and failed to menace. STANDING O chased outside a rival then went four wide into the turn, shifted to the three path around the bend then spun four wide into the stretch and weakened.
