HADES broke on top, set the pace along the rail around the first turn, disputed the pace in the two path on a loose rein down the backstretch, was headed by FIERCENESS leaving the half-mile pole, clung to that rival in the two path at a slight disadvantage around the far turn, regained command turning for home, drifted out under right-handed urging in the lane and drew clear. DOMESTIC PRODUCT broke out and bumped FIERCENESS at the start then rebounded inward and bumped DANCING GROOM soon after, rated in range inside, dropped back a bit early on the far turn, made progress at the rail late on the bend, swung six wide in upperstretch and ran onto gain the place. FIERCENESS had his head turned at the start and broke a bit awkwardly, was bumped by SEA STREAK and then immediately after by DOMESTIC PRODUCT, advanced four wide between foes around the first turn, disputed the pace between rivals down the backstretch, took the lead leaving the half-mile pole, dueled in the three path around thefar turn, lost the lead turning for home and weakened through the final furlong. IN VEI GLED bumped with OTELLO at the start, pressed the pace outside of the winner around the first turn, vied between that foe and FIERCENESS down the backstretch, chased two wide around the far turn and faded in the stretch. DANCING GROOM was soundly bumped soon after the start, trailed inside for a half, went four widearound the far turn and never threatened. OTELLO bumped with INVEIGLED at the start, raced off the pace two and three wide and lacked a rally. SEA STREAK broke in and bumped FIERCENESS at the start, was strung out five wide around the first turn, prompted four wide down the backstretch, chased four wide around the far turn and came up empty in the lane.
