After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(FTBOA offers up to \$20,000 to the owners of Registered Florida-breds, divided \$10,000 to the winner, \$6,000 to second, \$4,000 to third). Weight: 124 lbs. Non-winners of a graded stakes since July 1 allowed 2 lbs.; a stakes race since April 1, 4 lbs.; three races other than maiden, claiming, starter or state bred allowance, 6 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2022–24, stakes placed in 2022–24 then by highest career earnings. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 59 feet).

PANTHER ISL AND tracked in the two path, swung out to the six path under a ride turning into the lane, ran on to lead while tipping in passing the eighth pole, but was caught in the closing stages by an inner foe to place. EAMON N trailed in the three path turning into the stretch, angled out to the seven path passing the eighth pole, and rallied for show. CAROT ARI chased in the four path, was coaxed along while fanning out to the seven path turning into the stretch, and finished evenly. HOPE IN HIM pressed in the three path, bid around the turn, but faded from the four path in the stretch. THAT'S RIGHT was sent from the gate to set the pace along the inside but yielded in the final furlong. HEAVEN STREET stalked inside but backed up around the turn.
