STONE SILENT was prompted along while up close in the two path, bid whilefloating out to the five path at the top of the stretch, and drew clear. CHOOSE JOY bumped with an inner foe at the start, raced off the pace in the three path, was ridden into the turn, angled out to the seven path at the top of the lane, and ran on while on her left lead for place. FULMINATE set the pace in the two path, was cued while tipping out to the four path in upper stretch, but evened out for show. SHASTA STAR trailed in the four path, was coaxed in the three path midway around the turn, fanned out to the nine path at the top of the lane, and stayed on. BABY STEPS stalked in the three path, was cued midway around the turn, swung from the six path into the stretch, but flattened. GLITTER UP chased in the two path, cut the corner turning into the lane, but faded on her left lead. CANADIANSWEETHEART tracked in the four path, was cued between foes in the two path midway around the turn, but weakened in the stretch. THE ARCADIAN WAY bumped with an outer foe at the start, rated inside but steadied going into the turn, and was no menace.
