MISSED THE CUT rated along the inside through the early going, drew closer on the far turn still patiently handled, cut the corner into the lane, launched arail bid and gained command in upper stretch, then drew clear from the runner-up in the final sixteenth. PL ANETARIO (BRZ) settled at the back and steered inward, drew closer in the middle stages, continued to save ground around the far turn, angled out and bid four deep while getting bumped in upper stretch and got outkicked by the winner in deep stretch. BALL ADEER stepped to the front and crossed over to the inside, showed the way with a comfortable lead up the backstretch, unchallenged to the quarter pole then was confronted by IRISH PROPHET past the marker, drifted out and bumped that rival in upper stretch and relinquished the lead to MISSED THE CUT, no match for the top pair in the latestages but kept on to save third. IRISH PROPHET closest in pursuit in the early stages, traveled along the rail to the far turn, moved out and launched a bid in the two path past the quarter pole, got knocked into outer rival by BALLADEER in upper stretch and got edged for the show honors. EASTERN OCEAN traveled near the back off the rail then moved inside, gained in the two path on the far turn but flattened out in the final furlong. SHORT MAN reserved early outside a rival, rounded the far turn three then two wide and failed to respond when a sked. FOLLOWING AN INQUIRY, THE STEWARDS DISQUALIFIED BALLADEER FROM THIRD TO FOURTHFOR DRIFTING OUT AND MAKING CONTACT WITH IRISH PROPHET IN UPPER STRETCH, COSTING THAT RIVAL A CHANCE AT A BETTER PLACING.
