STARTING OVER rated inside, tipped outto the three path down the backstretch, was cued while four wide early around thefar turn, tipped out to the eight path turning into the lane, rallie doutside of foes into the final furlong, and got up in the final strides. TAW NY PORT laid in range around the two path, was roused into the final turn, sw ung from the five path into the stretch, ran on to lead passing the sixtee nth, but was caught by an outerfoe late to place. ANGLOPHILE la id in midpack along the inside, tipped out to the two path down thebackside, bumped w it han inner foe while merging to the rail going int o the final turn, swung from the four path into the lane, and kept on to be up for show. KINGMAX (IRE) settledin midfield in the two path, tipped out to the four path down the backstretch, was coaxed along while ranging up thr ee wide approaching the quarter, kicked on between foes from the six path in the stretch, but was out-finished to miss minor rewards. MAIN EVENT pulled around the first turnto set an open pace in the two path, came under a ride along the rail early into the final turn, stayed on from the two path into the stretch, but was caught by an outer quartet in the final sixteenth. HEADLINE NEWS stalked under a hold along the inside, had to wait along the rail rounding the finalturn, was roused at the top of the lane, had to steady and alter outwards passing the sixt eenth, and could not bid. DYNADRIVE race d off the pace in the three path, was coaxed while fiv e wide passing the quar ter, and did not thr eaten. SIX MINUS was unhurried in the two path early, was cued from the threepath int o the final turn, but ma de no impact in the four path down the lane. CALYCANTHUS tracked in the two path but weakened from the five path in the str etch. CATCH THAT PARTY hesitated at the start, then was held up while racing in the back of the pack along the inside, moved up from the rail down the backstretch but bumped with an outer foe and had to check going int o the final turn, but was no menace. AN OBJECTION LODGED BY THE RIDER OF KINGMAX (IRE) AGAINST THE RIDER OF STARTING OVER FOR INTERF ERENCE IN THE STRETCH WAS DISALLOWED,
