POUNCE was off a bit slowly, trailed two wide around the first turn, advanced two wide between foes around the far turn, swung seven wide in upper stretch, surged outside and was up in the final strides. LIFE'S AN AUDIBLE raced off the pace two wide around the first turn, advanced at the rail around the far turn, swung six wide in upper stretch, made good progress, took over near the sixteenth pole but was outkicked in the final strides. OZARA (IRE) tracked the pace from the rail, tipped two wide around the far turn, was floated five wide turning for home, took the lead in upper stretch, led to the sixteenth marker and was outfinished. CROWN IMPERIAL saved ground off the pace, cut the corner into the lane, made progress in upper stretch but flattened out in the final furlong. MYSTIC LAKE set the pace in the two path, drifted out turning for home and weakened. TIME TO DAZZLE was hard held four wide and faded in the lane. MACANGA prompted the pace two wide and faltered around the far turn. SHOW OFF was in range three wide and stopped midway around the far turn.
