OZARA (IRE) tracked the pace from the rail, tipped two wide around the far turn, was floated five wide turning for home, took the lead in upper stretch, led to the sixteenth marker and was out finished. CROWN IMPERIAL sav ed ground off the pace, cut the corner int o the lane, made progress in upper stretch but flattened out in the final furlong. MYSTIC LAKE set the pace in the two path, drifted out turning for homeand weakened. TIME TO DAZZLE was hard held four wide and fade din the lane. MACANGA prom pted the pace two wide and falter ed around the far turn. SHOW OFF was in range three wide and stopped midway around the far turn.
