OSCAR ECLIPSE bumped between foes at the start, prompted the early pace in the three path, received a right handed cue going by the thr ee-eighths pole, bid from the five path in upper stretch, took command passing the sixteenth, and held offa late charging outer foe. DREAMING OF KONA broke in and bumped an inner foe, rated in the four path, was coaxed while three wide midway ar ound the turn, swung from the five path into the stretch, had to alter out to the sixpath just after the eighth pole, and ran on for place. IMPLEMENTATION raced off the pace in the two path, was coaxed early ar ound the turn, angled out to the seven path at the top of lane, and kept on for show. VIVIR CON ALEGRIA (CHI) laid up close in the two path, was cued from the rail passing the thr ee-eighths, but finished ev enly along the inside in the stretch. LONGRANGE TODDY tracked in the three path, was ridden from the two path into the turn, but evened out in the four path down the stretch. LEGACY ISLE bumped with an outer foe at the start, set the pace in the two path, was cuedalong the inside midway around the turn, but flattened in the in the three path in the final furlong. TICKING got bumped by an outer foe into an inner foe at the start, stalked in the five path, was driven in the four path ar ound the turn, but floated out to the nine path at the top of the stretch, and weakened. SHAQ DIESEL got pinched at the start, chased along the rail early but never thr eat ened. THOUGHT trailed in the five path early and never menaced.
