TOO MANY KISSES was squeezed back from between rivals leaving the chute, settled well off the early pace while saving ground, eased out and around a rival leaving the three eighths, dropped back into advance inside a foe nearing the lane, came back out and worked her way between runners leaving mid stretch, shifted out as the leader drifted, closed in under right handed asks, took overlate and edged clear. ROYAL WHISPER, a bit rank leaving the gate, steadied soon after then angled out and rushed up four wide outside runners to take command, edged clear near the half, moved away while guided inward around the turn, remained well clear under a drive past mid stretch, drifted out late and gave way grudgingly. BAY STREET vied inside ROYAL WHISPER early on, rated back off that one and angled out near the half, stalked around the turn, was under pressure three wide pursuing in upper stretch, stayed on with effort to deep stretch then flattened out. BELLA BETTINA, three wide between rivals leaving the far turn, angled out and picked up some momentum, closed in while about five wide past mid stretch then failed to seriously sustain. MY FLICKER settled off the pace whilesaving ground, angled out then back in past the five sixteenths, edged up along the rail in upper stretch, chased and faded. SULTRY SALLYH, three to four wide, made a mild run leaving mid stretch then failed to sustain. FAST TRACKED moved up towards the rail near the half to chase the leaders, appeared to want to get out leaving the far turn, dropped back, swung out well wide in the drive and failed to threaten. GOLDEN TABBY prompted the early pace off the inside, faltered between rivals near the five sixteenths, was pulled up in upper stretch while bleeding from both nostrils then was vanned off.
