JAXON TRAVELER stalked the two leaders up the backstretch, advanced on that pair late in the turn, challenged three wide and between horses entering the stretch, narrowly showed the way past the furlong marker, dug in late and found just enough to gain the nod at the wire. TEJANOTWIST last away, moved out three wide for the run up the backstretch, closer four wide turning for home to concede real estate to three of his four rivals, regathered, set down with vigorous left then right handed crop, was going willingly at the end only to miss the nod. RYVIT dueled up front along the inside, continued to battle between horses into and through upper stretch, proved stubborn until late before yielding to the top two. SURVEILL ANCE moved up to duel just after the start, continued to alternate up front into and through the turn in the two path, battled on between horses with a furlong to run then yielded late. OSBOURNE lacked speed, raced in the two path behind the first flight through the turn, had little for the drive.
