DU JOUR settled in the two path off the pace, gained along the rail then two wide on the far turn, cut back to the fence in upper stretch and surged to the front, kicked clear past the eighth pole and was kept to busy to the wire. EASTER (FR) broke a step slow, traveled outside a rival at the back of the field in the early going, steadied behind MACKINNON at the three-eighths pole, chased three deep midway around that bend, swung five wide into the stretch, finished well through the lane and gained the place honors. AH JEEZ raced along the inside at the back, trailed from the fence through the far turn, tipped out into the lane, chased between rivals with a sixteenth remaining and gained third. FIRST PEACE was closest in pursuit three then two wide early, drew closer on the far turn and loomed three wide into the lane, challenged from outside in upper stretch, could not kick on with DUJOUR past the eighth pole and flattened to fourth. DANDY MAN SHINES (IRE) stalked between around the first turn then outside arival on the backstretch, angled out on the far turn and came four wide into the lane, then flattened in the furlong grounds. GOLIAD sprinted to the front and moved into the lane, yielded to rivals on both sides approaching the eighth pole and weakened in deep stretch. PRINCE ABAMA (IRE) stalked the pacesetter from inside, inched closer on the far turn, asked right handed leaving that bend and weakened in the drive. MACKINNON stalked outside a pair of rivals through the first turn, race doff the rail then moved inside on the far turn and steadied between rivals near the guarter pole and tired in the lane.
