KINZA brushed leaving the gate by outside rival, emerged from between rivals in opening yard to gain front and secure the inside, controlled pace, edged away around the second then padded cushion in upper stretch and stretch that margin further through the lane under some urging before being geared down in final yards. WHERE'S MY RING settled four wide into first turn, remained on same path into backstretch, later came in slightly in upper stretch, moved past SHE'S ATE MPEST passing sixteenth marker and proved second best. SHE'S A TEMPEST came in bit and brushed with winner in opening strides, prompted the pace outside pacesetter to second turn, was under ride to remain close around last bend, remained inside and was collared through the drive for the place. UL TIMATE AUTHORITY chased while bit off the rail, continued on two wide path, shifted outfur ther on last turn, was four wide entering the stretch and continued evenly to gain minor award. SHILOH'S MISTRESS stalked from the inside, dropped back some around the second turn and lacked nee ded late response. NAY V BELLE chased two or three wide into backstretch, remained off the rail, dropped back readily in upper stretch and was eased later in the lane and walked off. IFUAINTFIRSTURLAST unhurried in opening quarter, trailed while well off the rail, dropped further back to second turn, was eased into the stretch then eventually pulled up at sixteenth marker and walked off.
