PEPPER MILL, right to the early lead, setthe pace near the inner rail and gave way grudgingly. DELUSIVELY, a forward factor inside horses, flattened out and drifted out late. GOLDEN GOPHER raced inside horses on the far turn, moved off the rail turning for home, worked between horses and rallied. ASCENDANCY, rated back soon after the break, circled the far turn four wide, railed to menace and passed tired horses. GRACE PERIOD (FR), three wide the first turn, chased the pace outside horses and weakened. LOVE TANK lacked speed, raced inside horses in the stretch and passed tired ones. FREE AND HUMBLE, three wide the first turn, remained outside horses down the backstretch and gave way. STRESSED chased the pace racing outside horses and gave way.
