MISS HARRIETT quickly established command, set the pace inside while handling outside pressure, dug in when collared by the winner, fought on to mid stretch then gave way grudgingly through the final seventy yards. GRAMMY GIRL, three wide around the first turn, tracked under rating while remaining three wide to the half, dropped in a path and applied pressure around the far turn, failed to go with the leaders nearing the quarter pole and tired. SHIMMERING ALL URE, off the pacewhile in about the two path, was put to a strong ride leaving the five eighths, failed to respond around the final turn, faltered, was eased through the lanethen walke doff.
