LANDLORD in the second flight under light restraint inside, continued to track the dueling leaders through the turn, shifted to the outside for the drive, late bid outside the winner, missed. CHEZ WHIZ void of speed for a half, swung out widest for the drive, closed with good energy out in the strip to be rapidly getting to the top two late. TWENTY TO PARK forwardly placed while just off the inside, loomed closer three wide turning for home, flattened out the final furlong to finish up evenly. STRIKE RIDGE away in good order, pressed the issue winner early from the outside, dueled through the turn and into upper stretch, first to blink past the furlong marker. GOD'S COUNTRY lacked speed, four wide exiting the turn, improved position with some modest late interest without posing a threat. HOLUS BOLUS went one paced throughout while racing in the two path. RANCH HAND in the second flight outside, fell back turn, not a threat through the lane. TOU CHDOW NARKANSAS in the second flight while racing three wide, gave way in the drive. ROCKET SANDERS remained back while racing inside.
