GUN PILOT in the second flight three wide and between foes, roused for the drive, slowly getting to the winner. TAPATIO LEO broke well, set the pace in the two path, could not match the winner in upper stretch, gradually weakened, saved the show. CHASING TIME in the second flight while along the inside, came up empty for the drive. TUT'S REVENGE back off the pace off the inside, three wide and behind horses into the stretch, split rivals and improved position. MISTER ICEMAN in mid pack while outside, five wide through the bend, lacked a closing kick. SIR WELLINGTON off a step slow, raced back in the two path, dropped to the inside late in the turn, improved upper stretch then flattened out a bit. KAVOD in the second flight while between horses for a half, faded through the stretch. MORELLO forwardly placed, four wide through the turn, tired in the drive. ALTO ROAD broke back, trailed throughout, not a factor.
