TX WOMEN FOR ARTS in these cond flight while racing three wide, shuffled back steadily in traffic second turn, slight bother late in the final bend, set down when clear for the drive, finished willingly to be up late for the show while between horses. I'M A MESS last away, trailed early, raced four wide through the second turn, staged a belated rally while widest to improve position late. XTREME SMOKE SHOW settled in mid pack while three wide in the first turn, angled out four wide turning for home, went flatlate. BLUE SQUALL forwardly placed inside, continued to save some ground second turn, traffic behind the leaders, lacked a late punch.
