By free subscription. \$1,500 to pass the entry box, \$1,500 to start, with \$300,000 Guaranteed, of which 60% to the winner, 20% to second, 10% to third, 6% to fourth, 3% to fifth and 1% to sixth. Weight: 124 lbs. Non-winners of \$150,000 at a mile or over allowed 2 lbs.; \$100,000 at a mile or over, 4 lbs.; \$70,000 at a mile or over, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating allowances). All Black-Eyed Susan starters and also-eligible horses must be stabled at Pimlico Race Course by Tuesday, May 14, 2024. GUN SONG broke well and stalked the pace outside JEANNE MARIE, rated comfortably down the backstretch, advanced to take command in upper stretch and drew off under intermittent urging. CORPOSO bumped with RECHARGE soon after the break, never far back while three wide around both turns, was brushed and herded wide by CALL ANOTHER PLAY in upper stretch, remained on her left lead until well inside the sixteenth pole and gained the place. CALL ANOTHER PLAY raced in the two path between horses for seven furlongs, angled out in upper stretch herding CORPOSO then finished gamely inside that one. WHOCOUL DASKFORMO, taken up in tight quarters entering the first turn, raced in the two path down the backstretch, swung wide leaving the far turn then came up empty. LEMON MUFFIN, squeezed by RINGY DINGY leaving the starting gate, trailed behind horses, swung outside near the sixteenth pole and passed tired rivals. RINGY DINGY bore out leaving the starting gate, was rank entering the first turn, remained inside horses throughout and weakened. JEANNE MARIE, clear early, set the pace along the inner rail then weakened through the stretch. RECHARGE stumbled at the break, bumped with CORPOSO leaving the starting gate, circled the first turn four wide and the far turn three wide and failed to threaten.
