

7 FURLONGS. (1.20) DEL MAR FUTURITY Grade I Purse \$300,000 FOR TWO-YEAR-OLDS (FOALS OF 2022). By subscription of \$300 each if made on or before Friday, June 21, 2024, the fee to accompany the nomination. Closed with 125 For horses not nominated, supplementary nominations of \$10,000 each will close at the time of entry, Closed with 1 (Mckinzie Street) Thursday, September 5. All horses shall pay \$4,500 to start, with \$300,000 Guaranteed, of which \$180,000 to first, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Weights: Colts and Geldings, 123 lbs.; Fillies, 120 lbs. Non-winners of \$50,000 allowed 3 lbs.; \$30,000 other than claiming 5 lbs. High weights preferred. Total non-claiming purse earnings will determine the order of preference for horses of equal status. The Del Mar Futurity has been selected as a Breeders' Cup Dirt Dozen Race for the \$2 million FanDuel Breeders' Cup Juvenile on November 1, 2024 at Del Mar. The nominated winner of the Del Mar Futurity will receive a credit of \$30,000 toward entry fees into the 2024 Breeders' Cup Juvenile, 2nd place will receive a \$15,000 credit toward entry fees and 3rd place will receive \$7,500 credit toward entry fees. A trophy will be presented to the winning owner.

GAMING climbed a bit early then drew closer from inside up the backstretch, tipped out and drew alongside GETAWAY CAR at the five-sixteenths pole, seized command leaving the turn, kicked clear in upper stretch and remained strong to the wire under left-handed encouragement and strong handling. MCKINZIE STREET stalked the top pair keenly in hand early, suffered a mild shuffle at the half-mile pole, chased three wide through the turn, finished determinedly down the lane but had to settle for second best. CITIZEN BULL allowed to settle outside a rival at the back, gained four deep around the bend, flattened in the late stages but was able to hold third. GETAWAY CAR dueled from inside, inched ahead from outer rival at the half-mile pole, cleared leaving the backstretch, confronted by GAMING midway around the turn, relinquished the lead approaching the stretch and weakened in the drive. R HEISMAN raced in range between rivals, got crowded a bit at the half-mile pole, steadied leaving the backstretch, angled out in upper stretch and lacked the needed response. RANK climbed in the early going at the back of the field, raced in the three path entering the turn, angled out and was driven five wide into the stretch but failed to rally. BROTHER TONY dueled from outside then pressed inner rival at the half-mile pole, could not keep up approaching the turn, dropped back around the bend and tired.
