KING OF GOSF ORD (GB) took control from the start, showed the way along the inside under pressure from ATITLAN, maintained a short lead through the far turn, roused entering the lane, inche daway from ATITL AN and asked right handed outside the eighth pole, switched to the left hand in the final sixteenth and remained clear under steady handling. STAY HOT stalked along the rail, given his cue while tipping two wide at the quarter pole, moved out further at the top of the lane, finished determinedly in the final furlong and edged ATITLAN for the place honors. ATITLAN pressed KING OF GOSFORD (GB) from outside, hounded that rival to the top of the stretch, could not keep contact with that rival approaching the final furlong and got outkicked by STAY HOT for second. LORD BULL INGDON settled in the two path then found the rail on the clubhouse turn, continued to save ground around the far turn, steered out in upper stretch and kept on to earn a minor award but needed to find more to be a threat. CATHAL (IRE) traveled on the inside then two wide at the back, continued at the back along the rail then in the two path on the far turn, came out and bumped HEART HEADED in upper stretch and failed to menace. CALL SIGN SEVEN tucked inside off the pace, went two wide into the far turn, moved out and came four wide into the stretch, got floated out slightly in upper stretch and lacked a rally. HEART HEADED away quickly then taken back a bit to a stalking position, became rank briefly on the clubhouse turn, followed in range up the backstretch, chase d two then three wide on the second bend, got bumped by CATHAL (IRE) in upper stretch and weakened.
