

1 MILE. ( 1.332 ) 3RD RUNNING OF THE BRUCE D. MEMORIAL PURSE \$75,000 FOR THREE YEAR OLDS. Nominations close Wednesday August 2, 2017, with no fee. A Supplementary nomination of \$500 may be made on Wednesday August 9, 2017, which includes entry and starting fees. Original nominees to pay \$100 to pass the entry box and an additional \$100 to start, with \$75,000 Guaranteed; after payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. WEIGHT: 122 lbs. Non Winners of \$50,000 in 2017, allowed 3 lbs.; \$35,000 once or \$20,000 twice in 2017, allowed 5 lbs. (Maiden, Claiming and Starter races not considered.) This event will be limited to (12) twelve starters. High Weights preferred. Preference of horses of equal weight will be Highest Total Earnings in 2017. Failure to draw into this race at time of entry cancels all fees. Starters to be named through the entry box at usual time of closing. Two (2) horses having common ties through ownership cannot start to the exclusion of a single ownership interest. Trophy to the owner of the winner. Nominations closed Wednesday, August 2, 2017 with 31.

HARMAC stalked the pace on the inside while running in the two path, had no room to run with a wall of horses in front of him at the quarter pole, swung out at the three sixteenths pole and closed willingly from there. SMOKE 'N' GLOAT broke inward then quickly got into stride to duel for the lead on the inside, took the turn in the two path then edged clear from rivals at the top of the stretch but was outfinished by the closer. KITTEN'S CAT chased the pace between horses while running in the three path, ran gamely down the stretch but did not have enough. SOCIETY BEAU was void of early speed while running in the two path, stayed at the back well into the stretch then uncorked a strong late gain down the lane. MEMORY BANK bobbed into stride and bumped with UNCONTESTED in the process, shrugged it off and got up to stalk the pace on the outside, went around the turn in the six and seven path then had no response when asked. GAIN GROUND stalked the pace between horses while going around the turn in the four and five path, had no response when asked for more. UNCONTESTED bobbed at the start then bumped with MEMORY BANK, recovered to get up and duel for the lead on the outside going around the turn in the three and four path then came up spent for the drive. YORKTON stumbled at the start but recovered to stalk the pace between horses, took the turn in the four path then had no response.
